First and foremost, thank you all so much. I am grateful and overwhelmed by the fact that so many care about this matter. I read all of the e-mails and postings and want to say 'hello' to all my friends, old and new. All are shocked by the new evidence proving that Judge Madden and the false-accuser, Connie Vargovich, had a very "cozy relationship" going on before my trial, and that they were even seen out together while she and I were living together. No wonder I was railroaded. Sending me to prison was Judge Madden's favor to Connie and he called on his buddies the DA and sheriff to help. His reward was to have Connie indebted to him. Judge Madden was so eager to 'collect' on that debt that he couldn't even keep his hands off her during breaks in my trial. How sickening that my life is less important to the Judge than his obtaining sex from Connie. This is very important: I ask each of you to please send an e-mail telling me what you think of this Madden-Vargovich relationship, the fact that Judge Madden did not recuse from my case, and that he did not inform me of his relationship with my girlfriend which prevented me from demanding a different judge. Public opinion concerning this issue is important to my case.

The judge, DA, and sheriff **know** Connie falsely accused me. They just don't care. These are very cruel individuals concerned only about themselves. I always held on to hope that Connie has a heart, and hoped that it bothers her to know I'm in prison because of her rape lies. But she proves that she is quite heartless, without conscience or morals, and without regard for human life. Connie is mentally ill and needs help., which is why I hold the Judge and DA more accountable. They know I'm falsely accused, have the power to release me, yet do nothing but lie and cover their own butts. They surely want Connie to keep silent so that she doesn't further implicate them. In fact, Connie may need protection from them because they will do *anything* to keep their jobs. (Judge Madden makes over \$119,000 a year).

DA Lipske and Sheriff Bruneau are Judge Madden's puppets, and are parties to crimes. This is why they refuse to investigate the perjury, obstruction, and felony misconduct in office. They didn't investigate prior to my trial, won't investigate now, but instead protect each other. When outside law enforcement arrests Connie, she will implicate them in crime. If Connie has any common sense, she will throw in the towel, confess she falsely accused me, and assist law enforcement in taking down a corrupt judge, DA, and sheriff before they pin it all on her first.

It's proven *ten times over* that I'm wrongly convicted and that these officials knew it all along. They don't deny I'm wrongly convicted (if they did, the entire town would laugh at them). These people believed that nobody would care about Don Miller, a lowly TV-repairman scratching out a living. They were wrong, and now they are caught.
